

## **LIABILITY WAIVER RELEASE FORM - REQUIRED**

The individual signing this Liability Release Waiver ("Waiver") certifies that he/she is the Parent/Guardian/Player 18 Years of age or older ("Adult") and accepts this Waiver on behalf of the Player named below for training, clinics, camps, events, tryouts, teams, and open gyms held by Limitless Basketball Florida, Inc. ("Company") and recognizes that there are risks of damage or injury arising from participation in the activities.

The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and, **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or other and assume full responsibility for my participation;** and, I willingly agree to comply with the stated and customary terms and conditions for participation.
