It also indicates your acceptance of the Club/Team Fee Agreement as defined below.

MEMBERSHIP & CLUB/TEAM FEE AGREEMENT TERMS

I/WE, AS THE PARENT/GUARDIAN AND MY SON understand that by accepting a place on the Limitless team listed below, that we will participate in all team related events throughout the full seasonal year. We also understand that Limitless is a premier travel basketball organization and that by agreeing to this commitment my son will not participate in any games with another premier travel basketball organization during this commitment time.

Furthermore, **I/WE, AS THE PARENT/GUARDIAN**, understand that our acceptance indicates an agreement to fulfil all financial obligations to the Club and the team for the 2022/23 travel basketball year. We fully understand and consent to the following terms and conditions regarding the Limitless Travel Basketball Club costs as outlined in the Limitless Club Fees sheet for our child's assigned team ("Club Fees") AND the estimated budget provided by the individual team coach/manager ("Team Fees") as well as Limitless membership and privileges:

1. We are responsible for the entire season's Club Fees and Team Fees. Limitless may, in its sole and total discretion, offer a payment plan for Club Fees and/or Team Fees; however, such option in no way waives any obligation for full payment of all sums due for such Club Fees and/or Team Fees.
2. Failure to pay the Club Fees and/or Team Fees by the applicable due dates established by Limitless may, at the sole and total discretion of Limitless, result in suspension of membership in Limitless in addition to late fees and interest as set forth below. The continued failure to pay Limitless Club Fees and/or Team Fees for a period of thirty (30) days will result in automatic loss of membership standing, and the player will no longer be able to participate in Limitless team trainings, games, or activities.
 1. I understand that, under the payment plan agreement, a \$25 late payment fee plus interest of not less than the prime rate plus 2% per annum will be assessed to my Club Fee account for any Club Fee and/or Team Fee payments not received within ten (10) days of the due date set forth on the Limitless Fee Information sheet.
 2. I also understand that the player may be suspended from Limitless training, games, and activities if payment for Club Fees and/or Team Fees is not received within 30 days from the due date set forth on the Limitless Fee Information sheet and/or the Team Fee payment schedule.
3. If we withdraw, are suspended, or are terminated from the Limitless program for any reason whatsoever, we acknowledge that we are not entitled to any refund of Club Fees and/or Team Fees previously paid, and we shall remain responsible to Limitless AND the team for the entire year's costs.
4. If we default in payment of our Club Fees and/or Team Fees for any reason whatsoever, we are liable for all costs and expenses incurred in collecting the same, including, but not limited to, reasonable attorney's fees, collection fees and court costs.
5. In the event that Club and/or team related activities, including live games and practices, are banned or otherwise cancelled due to an express State of Emergency and/or Governor Executive Order (collectively "Restrictions"), Limitless will communicate a policy of possible extensions, refunds and/or credits of Club Fees and/or Team Fees following determination of the extent and time period of such Restrictions. This provision is not intended to be exclusive and shall be implemented in the sole discretion of the Club based upon known and relevant circumstances.
